Article 1. Company information

The PixDura brand name of Rixus BV with its registered office in 5555XP Valkenswaard at De Vest 34, represented by Mr. Fahim Farhad.

Article 2. Personal data

PixDura brand name of Rixus B.V. processes your personal data because you use our services and/or because you provide this data to us yourself. Below you will find an overview of the personal data we process: - First and last name; - Gender; - Address details; - Telephone number.

Article 3. Purposes of the processing / legal basis

The above-mentioned personal data are processed for the following purposes: - Delivery of products;

- Sending newsletters and/or advertising; Executing and drawing up a purchase agreement; PixDura brand name of Rixus BV processes personal data in accordance with the following legal basis.
- Supplier agreement; Newsletters and information about our services;- Maintain contact about services, products and the associated service;

Article 4. Storage period

PixDura brand name of Rixus BV will not store the collected personal data longer than is strictly necessary, or regulated by law, to achieve the purposes for which the data was collected. To this end, we use the following retention periods for each purpose: - legal basis: two years; - sending newsletters and/or offers: two years; - telephone contact: two years; - informing about changes to services: two years.

For the personal data for which statutory retention periods apply, PixDura brand name of Rixus BV adheres to the statutory retention periods.

Article 5. Sharing with third parties

PixDura brand name of Rixus BV does not provide your data to third parties and will only provide it if this is necessary for the execution of our agreement or to comply with a legal obligation. If we provide your data to third parties for other reasons, we are obliged to ask for your consent first. Insofar as relevant, a processing agreement will be concluded with these third parties, or it will be checked whether this party handles the processing of personal data correctly.

Article 6. Safety

PixDura brand name of Rixus BV takes appropriate measures to prevent misuse, loss, unauthorized access and other undesirable actions with personal data. These measures are in accordance with applicable security standards.

Article 7. Rights of data subjects

You have the right to view, correct, supplement, delete and/or object to your personal data. Make an appointment for this via PixDura brand name of Rixus BV. It is possible to submit a complaint to the supervisory authority, the Dutch Data Protection Authority. You also have the option to withdraw your consent to the processing of personal data at any time. You must also submit a request to PixDura brand name of Rixus BV for this. It is important that you can identify yourself and prove that the data you want to view, correct or delete really belongs to you. It is not allowed to view other people's data.
